

Before you click on Submit, check for accuracy: spelling of names, phone numbers, day, date and time. When writing your article, have on hand a calendar and SCOV Community Phone Directory.

When and How to Submit

- Deadline is the 8th of the month prior to the month of publication. Publication of late submissions is not guaranteed.
- Submit every month, even if there is no change.
- Club information not updated by the Article Deadline may be removed.
- Please have only one submitter per club.
- Each club may have one article in the **Clubs** section.
- Events or classes open to the community may also be listed in Coming Events or Workshops and Classes sections. Events open only to club members may be listed under Special Events for Clubs.

Accessing the Tipster Form:

Submit using our website **www.scovaz.com** > **News & Info** > **The Tipster** > **Submit Article** (see picture, page 3).

Complete the form (see sample form, page 5 at right).

Type your email address carefully and confirm that there are no typos. If it's incorrect, you won't receive an acknowledgement.

Attach a photo if desired, must be a large JPEG, (see page 10).

Click on **Submit** button at the very bottom of the form.

Receive a Confirmation from the website system.

Watch for an email notice from Marsha Dean (see sample on page 9). VERY important – if you don't hear from Marsha in two to three business days of sending your article, email or call her, mdean@suncityorovalley.com, 520-917-8069.

General Guidelines

Day, Date, Time, Place and Cost: In that order.

Day and Date: Spell out in article text. Example: Saturday, February II, 7 PM, Auditorium. Abbreviate in article header and tables. Example: Sat., Feb. II, 7 PM, Auditorium.

Times: 6-9 AM; 6 AM-Noon; 6 AM-I PM; AM or PM all caps; no periods or spaces before/after dash.

Place (Building/Room): Spell out for easy recognition, except commonly abbreviated ones which are listed in the legend on page 2 of the *Tipster*. Examples: Catalina Vista/Pusch Ridge; AFC; WCI.

Contact and Phone Number: In header: Pres., John Public 520-825-0000, jqpublic@hotmail.com. In article text: Call John Public 520-825-0000 jqpublic@hotmail.com. (Not, "For further information call John Public at 520-825-0000.") No comma. Double-check spelling and phone number; use Community Phone Directory for reference.

Article Submission Form Word Limits and Placement

Articles submitted over the designated word length are subject to editing by the Tipster Editorial Committee.

Association GM and Board of Directors - 350 words

Association Committees - 150 words

Coming Events – 100 words (must be open to everyone)

Special Events for Clubs box – two lines (open to club members only)

Workshops and Classes - 75 words

For Your Information - 100 words

Celebrations and Life Events - 100 words

Thank You Corner - 50 words

In Memoriam – Name and date of passing only. *Please indicate if* current resident or former resident.

Clubs - 150 words

Town of Oro Valley - 100 words

Partnered Organizations - 100 words

Extended Community - 50 words

Classified - 50 words (\$10 fee)

Specific Guidelines

Refer to the Article Standards for complete guidelines. Listed here are a few common ones.

Acronyms: Use full name followed by acronym in parenthesis. Institute of Learning in Retirement (ILR).

Alcoholic Beverages: Articles should not mention beer, wine or alcoholic beverages for sale or provided free at a SCOV event. (A catering license and liquor license is required.) Use BYOB, refreshments will be served, beverages served, or sodas and beverages included.

Common Abbreviations: per person = pp; single = sgl; double = dbl; couple = cpl; Sun City Oro Valley = SCOV (preferred designation).

Email and Website Designations: email or website (no colon) and the address. Example: email jones@aol.com; website www.hotsheet. com (we have reinstated www so that links in the online *Tipster* will work).

Emphasis: Do not use exclamation points. Do not use all capitals.

Header: Abbreviate days and months using three letters and a period.

Listings of Events/Activities: Include only essential information; be brief and concise.

Numbers: 1-9 spell out (i.e., one, two, three, etc.), 10 and greater should be numerals.


